It is with great pleasure that we are able to report that the 2014 Docent Manual for Octagon House has been printed, copied, bound and distributed to those Dames interested in owning their own copy. Copies are still available here at Octagon House for \$20 each, payable either in cash, or by a check made out to NSCDA-CA. In order to avoid confusion, we suggest that you write your name on the outside of your manual as soon as you purchase a copy. As we have mentioned before, please shred any-and-all earlier versions of the manual rather than throwing them away in-tact.

This latest version of the Docent Manual contains a great deal of information about the history of Octagon House as well as the collection of decorative arts within it; it also contains a number of new appendices. This manual is, therefore, a lengthier version of its predecessor and, as such, is literally heavier to carry around. Please note that if it is too heavy for you, we have a solution. Given the way the manual was bound, it is very easy to separate out sections that you may wish to leave at home, while you carry the main section with you to Octagon House for an open house.

There are some "house copies" of the Docent Manual, kept on the book shelf in the telephone closet at present, for use by docents while they are in the house. *These copies are not to be removed from Octagon House at all.* Furthermore, for security purposes, we do not ever want a Docent Manual lent out to a nonmember. The contents of the manual may be used as a general reference guide for visitors who ask questions. However, there are explicit instructions within the guide informing docents NOT to discuss certain aspects or details about the house or the collection, so we ask that you become familiar with those instructions and honor them.

Gail Sollid is organizing various docent training sessions with interested Dames, so keep your eyes open for notices regarding these sessions. There will be one such session the second Thursday of November that I will help lead. I will also be part of a team of docents at an open house this coming Sunday. While we are always looking for help with docents and open house hostesses, we also welcome any and all Dames to simply come and visit the house as a tourist-of-sorts, bring your family and friends, and listen to the various introductions and general information given out by the docents at the house. Years ago, I had an algebra teacher who often claimed that the two elements of learning were: a little bit of fear of discovering something unfamiliar, and a lot of repetition to make the unfamiliar familiar. The more you listen to other docents and read the manual, the more familiar the house and collection will be to you too. We suggest just trying to learn about three things in each room for starters, and then branch out from there.

Lastly, although we are very proud of the work that went into creating this Docent Manual, we are realistic; as with most manuals, this one is not perfect. You may find errors, omissions or other points of interest as you review the manual, and we truly welcome your comments, corrections and constructive criticisms in response.

Thank you to all of those who contributed to the process of getting the manual updated and thanks to all for your patience while the process took its course.

Since our last Board meeting on May 13, 2014, the San Diego Committee took a summer break. Therefore, our next Board meeting is on Tuesday, September 9, at the home of Anne Marshall. Our annual Cocktail Party is on Sunday, September 28, at the La Jolla Country Club. And, our next scheduled Fall USO dinner will be on Tuesday, October 14 – an always inspiring event when we prepare a meal for our military members and their families. The menu will be, as usual, barbeque beef, potato salad, green salad, chips, rolls and lemonade. Desert will be a decorated cake and ice cream. We always plan for at least 150 people.

The Fall Business meeting will be on Tuesday, November 18, again at the La Jolla Country Club. This should be an informative and fun event as our speaker will be Clairmont High School social studies teacher, Jim Fletcher. Jim has a Museum of American Presidents at the school with over 40,000 items representing all 44 presidents. The State is currently seeking suitable items for the Casa from their other properties. Once they have what is available, they will look to the California Dames to contribute the remaining required objects. It is our plan to send an email to all Dames in California asking if they might have a desired piece and are willing to donate it.

With our funds, we have purchased one item that is a key piece in the restoration: a sculpture of the Virgin Mary. In July the figure suddenly appeared on eBay. Because the price was reasonable, we acted quickly and, happily obtained this essential statue. One of our members, Carol Shively, has found some books of the appropriate era which will be placed in the Casa.

Our October Board meeting is scheduled for the  $14^{th}$  at the home of Joan Stone. That evening we will prepare our semiannual meal at the local USO for our service personnel and their families.

Report of the Regent of Gunston Hall April 9, 2014

Madame President and Ladies,

In October I shall be heading back to Virginia for my final meeting as the California Regent of Gunston Hall. It has been an **honor** and a **privilege** to serve the California Dames, the National Society and the Commonwealth of Virginia for 10 years as a member of this board.

As you may know, through a 1932 "Deed of Gift" that became effective in 1949, the property of Gunston Hall was bequeathed to the Commonwealth of Virginia with management and supervision of this memorial to George Mason given to the NSCDA. Since that time, the Dames have worked enthusiastically and tirelessly to preserve the legacy of George Mason, and you can be assured that Gunston Hall is not only a "jewel in the crown" of NSCDA properties, but also one of the most beautiful and vibrant historic homes in the world!

In the last 10 years many changes have come to the property itself and to the way it is managed; the mansion has been "returned to splendor", lovingly and accurately restored to colors and architectural detail present in Mason's day (with a new, shingled Colonial style roof being installed this summer/fall); the collection has been expanded to include both original Mason family pieces, as well as things that the family would probably have owned; archaeological exploration has revealed much about the use of the property and has also uncovered items present in the house in Mason's day; a vista has been opened to the river, revealing a view Mason might have seen, and the grounds ,with their expansive fields , give visitors a feel for life at an  $18^{th}$  century home.

Educational programs for children and adults are interesting, numerous, expanding and well attended. Noteworthy this summer was the Naturalization ceremony held there as well as a reception for Mason Neck citizens (Mason Neck is the area where Gunston Hall is located) which took place <u>inside the mansion</u> (furniture having been removed and stored for roof replacement. We are fortunate in CA to use Octagon House for receptions, but Gunston has not been used this way for many years, so this was a rare treat).

In 2013 we hired a new, young, energetic and very capable Executive Director and, with the advice of a respected consulting firm restructured our board to become a "policy making" board rather than a "hands on operational board". We also became a corporation now known as the Board of Regents of Gunston Hall, Inc. We adopted a new mission and have a new strategic plan to make Gunston Hall a national and international center of learning about the Virginia Declaration of Rights .

October will be the first meeting as a restructured board. With our new mission in mind, the board, staff and docents will be treated to an educational program about George Mason's worldview and its sources as well as the evolution of Rights since George Mason's time. We want our future programs and marketing to accurately reflect Mason's ideas.

In 2016 Gunston Hall will be celebrating the 260<sup>th</sup> Anniversary of the Virginia Declaration of Rights. We are exploring events and programs about why this document is so important to the world and why it is so enduring. You can look forward to hearing much more about this during the coming year.

None of the things that happen at Gunston Hall would be possible without your support, and I want to sincerely thank everyone who has ever contributed. This year California Dames, many of whom may never have the opportunity to visit this beautiful place in person, have given \$4165.

I hope you have been receiving the "Gunston Grapevine" on line and want to encourage you to visit the Gunston Hall website. There is also a "blog" (gunstonhallblog.blogspot.com) and a new site for our gift shop! Something interesting is always posted!

**CONGRATULATIONS** to Nancy McAteer, who will become the California Regent at the October meeting!!. Gunston Hall is so fortunate to have her on the board, and we are so fortunate to have her representing us! As George Mason would have said in the 17<sup>th</sup> century "Huzzah"! ... or a 21st century "Hooray"!

# The NSCDA-CA Web Site Report to the NSCDA- CA Governing Board

September 9, 2014 Governing Board Meeting By Marguerite Christiansen, Communications Chairman

On March 5, 2014 we launched the nscda-ca.org website to the public. The following is a report of activity for the past six months.

# A) Website Use:

Since the March public debut and through August 31, the website has had 681 users (includes repeat users) with 1,495 sessions (multiple page views). Most sessions were from San Francisco (175), Santa Rosa (129), San Bruno (125), and San Diego (74). Fremont, San Rafael, Monterey, South San Francisco, Los Angeles and Mazatlán made the rest of the top 10 places.

#### D) Website Costs and Maintenance Plan with David Kerr Design

Keeping a website going requires 1) volunteer/staff time putting up and updating content, 2) tech support to resolve design issues and training volunteers/staff and 3) website technical maintenance.

Thanks to Kimberlee Caniglia, Marguerite Meyer, Connie Stone and my time, we shared a great deal of the content work.

Since the launch of the site in March, our tech support (item 2&3 above) costs have been 0\$ in April, \$125.00 in May, \$280 in June, \$170 in July. I don't think we had any costs in August.

In August, we signed up for a Website Maintenance Plan with David Kerr Design our website designer and developer. The new plan addresses item 3) above -- providing backup, extra security and WordPress maintenance (including plug-ins and other

more major WordPress changes.) Having David and Shannon Tilton, our web developer, look into things monthly is a great help. The plan is \$34.00 a month. We have prepaid it through the end of 2014.

This maintenance plan does not include any item 2) costs we might wish to have David and Shannon help us with, but we will do our best to keep these to a minimum, by helping each other.

## F) Next Steps

- We still need State Society Governing Board officers and chairmen's help with content. Please tell members of the communications committee when important dates are set or about information that our members or the public should know.
- Need to write a website administration policy to guide web content on public and private sides of the website and will include a record of all web photo licenses and applications used.
- Working to place content approved at the three workshops last fall on the members' only section of the website.
- Continuing to study website usage using Google Analytics.
- Need to schedule and hold periodic meetings of the Communication Committee to assist with using and editing the website.
- A second phase could be added in a year or more and would expand the member's only section to become a member portal. This portal would allow each member restricted access to update their contact information for the directory, share interests and more. Another element could be a candidate's portal too.

The Golden Gate Boy's Choir led us in singing our National Anthem and other patriotic songs. Food and drink were served and a multi-generational audience had a wonderful time.

Over the summer Kathryn Hobart and her team of appraisers spent many days at Octagon House evaluating for insurance purposes the collection and other items in the house. I worked with them throughout the process and learned a great deal about our fabulous collection and other important items in the house. Martha Steen, Chair of the Museum Committee for Octagon House, and I will meet with Kathryn to receive her report on Monday, September 8. Questions were raised regarding what should be done about the many valuable items in the house that are not part of the collection. It was recommended that a committee be formed to consider the best conveyance of these items.

Wooden Windows in Oakland is finishing the replacement sash for the window over the staircase along with several new sashes for smaller windows upstairs. They will be installed in mid-October.
