Gail Sollid NSCDA-CA President Even though we have not been busy docenting in the month of January, we have had several educational events for Dames and their guests and friends.

On January 14, 2015 we attended a docent tour of the Houghton Hall exhibit at the Palace of Legion of Honor. This private tour covered the history and preservation efforts on this home which had been built originally built by the first prime minister of England, Sir Robert Walpole. Rooms were recreated and some furnishings and video recordings enhanced the experience.

On January 15, 2015 we filled our Octagon House with Dames and guests for a fascinating lecture on the influence of octagon house architecture (and Orson Fowler) on modern architecture and society. James Dixon, a prominent San Francisco architect, gave a power point presentation complete with many pictures showing the evolution of contemporary architecture and the octagonal design influence on famous architects. Particularly interesting was Frank Lloyd Wright's own home in Illinois where he used a staggered octagonal ceiling design in his studio.

On March 4, 2015 we visited the Carolands in Hillsborough. This significant mansion built in Hillsboro by the heiress to the Pullman fortune is finally open to the public after many years. We had a Dames only private tour and were treated to a house which was built emulating the highest of French design. The house has now been restored and decorated to an exquisite level and is run by The Carolands Foundation.

The Book of Ancestors project is ongoing. All California Dames have been sorted by the ancestor name. Much new information has been uploaded to the website. We included an article in the recent Quill outlining how to participate. We hope to expand this project for the state of California. Please continue to visit the website to see the latest updates.

The National Society of The Colonial Dames of America In California MEMBERSHIP COMMITTEE REPORT

Regular Meeting of The Governing Board March 10, 2015 Octagon House San Francisco, California

The Membership Committee met on Wednesday March 4, 2015 at Nancy Maushardt's home in Sonoma. Nancy and Lucy Maushardt prepared a lovely luncheon for us and we thoroughly enjoyed being in the "the country" on such a beautiful sunny day! In attendance were Mesdames Gerlach, Kasanin, Matthews, L. Maushardt, N. Maushardt, and McCormick, in addition to Ex-Officio Member, NSCDA-CA Registrar, Juanita Dickson (Mrs. James Dickson).

We invited and welcomed Kirsten Vernon (Mrs. Robert Vernon), who will serve as NSCDA-CA Registrar following the annual meeting on Thursday, April 16, 2015. I provided copies of the "All" chart (listing all of the NSCDA-CA candidates statewide), as well as the "Northern California" chart, and we summarized the "steps" and the details tracking the status and progress of our California candidates that are noted on these charts for Kirsten. Juanita Dickson also had two binders she maintains as Registrar, and provided a quick review. Juanita and Kirsten plan to meet together, and I will join them, too, prior to the annual meeting in April. We are all delighted Kirsten will serve as a Registrar and will welcome her as an exofficio member of the membership committee as well as a member of The Governing Board!

The main topic of discussion at this committee meeting was how to manage queries from women who have sent e-mails to the national headquarters of the NSCDA or to Octagon House, after seeing either the national website or our beautiful California website, asking "how to join". As most of you may know, NSCDA-CA President Gail Sollid sends an e-mail reply, with the help of Kimberlee Caniglia, Octagon House Assistant, which outlines the two criteria for membership:

- One must be descended from an ancestor who rendered distinguished service by July 5, 1776, such as a colonial governor, an officer in the militia, a judge, or a clergyman.
- Secondly, membership requires sponsorship by current members who are well acquainted with the candidate.

Gail had asked the membership committee, in an e-mail dated 3/3/15, to "rewrite the letter that we do send to membership inquiries" noting that we could "add more specific information for membership requirements". We recommend Gail ask "How did you hear about us?" and "Where do you live in California?".

We suggest clarifying that the suggestions given of types of service are just examples, and the letter might read:

.... such as, but not limited to, a colonial governor, an officer in the militia, a judge, or some members of the clergy.

Apparently one woman did not understand that her ancestor's service in the House of Burgess qualified.

We also appreciate that Gail has added a statement in the outgoing letter that "There are Public Genealogical Resources available on the National website for NSCDA at www.nscda.org, which suggests that they begin to do some genealogical research on their own.

I also looked at the national website and printed **Chapter VIII**, **Suggested Replies to Letters of Inquiry Re: Membership**, which offered two suggested letters to send as replies "to an unsolicited request for membership", one of which is basically the exact template for our current letter, without the reference of the National website address. Since most of the queries are from women who have already looked at the website(s), you might reconsider including that website address again.

However, the consensus at the membership meeting, and expressed in several e-mails from members that I have received, is that the requirement that a prospective candidate must be proposed and seconded by members who know their candidate well for 2 years remain unchanged.

Reviewing the national website, please note the following:

The NSCDA Constitution, Article III, sets forth the eligibility of members as follows: *MEMBERSHIP*.

The Corporate Societies shall be composed entirely of women who are descended in their own right from some ancestor of worthy life who, residing in an American colony, rendered efficient service to his country during the Colonial period, either in the founding of a State or Commonwealth, or of an institution which has survived and developed into importance, or who shall have held an important position in a Colonial government, or who by distinguished services, shall have contributed to the founding of our nation.

DATE OF ANCESTOR'S SERVICES.

All services which constitute a claim to membership must have been rendered before July 5, 1776, but this date shall be held to include all signers of the Declaration of Independence.

Article V, Section 4, further explains the Corporate Societies role:

The members of the Corporate Societies of The National Society of The Colonial Dames of America at the date of certificate of incorporation of the Corporate Society shall be elected members of the corporation at the first meeting of the said Society subsequent to the incorporation, and thereafter <u>no person shall be a candidate for admission unless invited and proposed by one member and seconded by another member of the Society, to both of whom the candidate must be well known, and by whom she shall be recommended. The Board of Managers of each Corporate Society may decide whether to accept a candidate proposed by a member of another Corporate Society.</u>

Additional information is found in Acts in Council, Article XIII, Corporate Societies: Section 1. *Admission to Membership.*

a. A candidate for admission to a Corporate Society shall be proposed and seconded by any two members of the local Society. A candidate may also be proposed by a member of another Corporate Society if the Board of Managers of the receiving Corporate Society approves. Each of the 44 Corporate Societies may have other requirements for candidacy including that a prospective candidate be well known to several members of their Corporate Society Board.

* * * * * * * * * * * * *

Interestingly, one year ago, at the **March 4, 2014 meeting of The Governing Board**, the Membership Committee report focused on this very issue. We asked for opinions, regarding our current requirement that NSCDA-CA members know their candidates well for at least 2 years, and reported as follows:

"Some very important issues were discussed at length at the membership committee meeting on 2/3/14. We have had several instances lately when there has been some confusion over the "rule" that NSCDA-CA members need to know their candidates well for 2 years or longer.

DISCUSSION:

- (1) We need to stress that proposers must serve as mentors to their candidates and remain in close contact during the application process (bring them to events, check how they are doing with their papers, etc.), and share their concerns and updates with the Membership Chair(s) and/or NSCDA-CA Registrar for follow up.
- (2) Proposers (and all of our members) need to understand the rules and guidelines outlined in the blue Directory, regarding proposing and/or seconding candidates for membership.
- To propose a Regular candidate, you must have been a member for 2 years.
 - -- You must have known your candidate well for at least 2 years.
 - -- You find a seconder, and five endorsers.
 - -- You may only propose two Regular candidates and second two Regular candidates each year.

- To <u>propose a Legacy Candidate</u>, you do NOT need to have been a member for 2 years, and you only need to find a Seconder.
 - -- There are no limits to the number of Legacy Candidates members may propose and/or second each year.
 - -- Members may propose their own relatives (daughters, grandmothers, aunts, cousins, etc.), as well as candidates whose deceased relatives were NSCDA members."

President Gail Sollid has organized a "Meet and Greet," to be held on Saturday, March 14, 2015 at Octagon House, for several women who have sent e-mail inquiries. Also included will be friends of a few current members who have expressed an interest in joining NSCDA-CA, although I am not sure which members were asked whether they had friends they wished to bring. In any case, it promises to be a lovely event, and Gail may plan to hold additional "Meet and Greet" gatherings periodically throughout the year.

NSCDA-CA welcomed eight (8) new members since January 1, 2015. This is phenomenal!

- (1) The Membership Committee feels we should focus on welcoming all of our new members to help them learn more about the Society they have just joined and to encourage their participation in meaningful ways.
- (2) We want to continue to ensure that prospective candidates are well known to NSCDA-CA members for a period of 2 years or longer.
- (3) That is not to say that interested women who may attend a "Meet and Greet", or other events as guests, could not develop friendships with current members who then may propose them at a later date.
- (4) The committee is interested in knowing how this list of individuals who have submitted e-mail inquiries will be maintained, and whether forms will need to be revised to indicate the date their inquiry was received, etc.
- (5) The committee recommends that the management of unsolicited requests for membership, including the e-mail and U.S. mail communications and any such tracking lists with contact information, etc., be provided by the NSCDA-CA president, and/or her designee, rather than the Membership Committee.

California enjoys a robust NSCDA membership, in comparison to many other Corporate Societies, with close to 500 members statewide. The membership committee is anxious to serve our members and to facilitate their proposed candidates who are diligently working to complete the membership process. There are currently 68 candidates statewide – 38 Regular and 30 Legacy Candidates, with a total of 18 candidates in Northern California, 8 in the Monterey Peninsula, 20 in LA-P-SB, and 22 in San Diego.

Hopefully our surge in membership will continue and we can celebrate 2015 as a record membership year!

OCTAGON HOUSE MANAGER'S REPORT March 10, 2015

A new hot water heater was installed in the basement of Octagon House on February 25. In preparation for the installation, the plumbers discovered that the per inch water pressure on the pipes was too high. (90 lbs. of pressure per square inch vs. the desired 50-60 lbs.). A pressure valve and expansion tank were installed on the new hot water heater and on the main exterior pipe that runs along the back of the house to the right of the back door as you exit. The reduction of water pressure will relieve the wear and tear on our aging pipes. Very small leaks were noted under the house from old pipes. The plumbers recommended replacing these 1940's iron pipes with copper plumbing. There will be an inspection on March 10 at which time an estimate for the job will be given.

The kitchen sink faucet was replaced on February 25, as well. The gaskets that control the water flow were not engaging and the water couldn't be shut off. Pipes under the sink were inspected and tightened.

The NSCDA-CA Web Site

Report to the NSCDA- CA Governing Board, March 10, 2015

On March 5, 2014 we launched the nscda-ca.org website to the public. Many thanks to the Communications Committee of Gail Sollid, Ruth Donohugh, Marguerite Meyer, Judy Mack, Connie Stone and Kimberlee Caniglia. The following is a report of activity for the past quarter (Dec 1 – Feb. 28). Many thanks to all for pitching in!

A) Website Use:

Our first six months, from March 5 to August 31, the website had 681 users. From September through November the website had 913 users. From Dec. 1 2014 through Feb. 28, 2015, we had 1007 users - a 10% increase from the previous quarter. The following are some metrics from Google Analytics:

- 1) From Dec 1 to Feb 28, the website's had 1007 visitors using 1,341 sessions. There were 2,989 page views-2.23 pages per session. New visitors accounted for 959 (71.5%) of the sessions; returning visitors accounted for 382 (28.5%). Most sessions were from San Francisco (343), San Diego (87), Santa Rosa (46), and Monterey (35). Unset (no city), Los Angeles, San Jose, Berkeley, Washington made up the rest of the top 10 places.
- 2) Of the 1,341 sessions, 953 (71%) people accessed the website using desktop computers, 272 (20%) used mobile devices and 116 (8.65%) used tablets. Of the 1,341 sessions those using Google's Chrome's browser totaled 544 (40.5%), 465 (35%) used Safari's browser and another 16 (1%) used the Safari (in-app), Firefox and Internet Explorer were 146 (11%) and 145 (11%) respectively and Android Brower had 20 (1.5%) users.

D) Website Costs and Maintenance Plan with David Kerr Design:

1) Volunteer/staff time putting up and updating content

Kimberlee Caniglia, Marguerite Meyer, Connie Stone and I continue to share the content work.

2) Tech support to resolve design issues and training volunteers/staff

During this quarter, we had one bill from David Kerr Design in the amount of \$120.00 for work in January. This was to create an "expand/collapse" feature to help us present information on the website.

3) Website technical maintenance.

In August, we signed up for a Website Maintenance Plan with David Kerr Design our website designer and developer. The new plan provides backup, extra security and WordPress maintenance (including plug-ins and other more major WordPress changes.) In January we paid for this plan through December 2015.

E) Next Steps

- 1) We need your help with content! Please tell members of the communications committee when important dates are set or about information that our members or the public should know.
- 2) A website administration policy was drafted and needs to be finalized to guide web content on public and private sides of the website. It will also include a record of all web photo licenses and applications used.
- 3) Add content approved at the three workshops last year on the members' only section of the website.
- 4) Continue to study website usage using Google Analytics.
- 5) Need to schedule and hold periodic meetings of the Communication Committee to assist with using and editing the website.
- 6) A second phase could be added in a couple of years or more and would expand the member's only section to become a member portal. This portal would allow each member restricted access to update their contact information for the directory, share interests and more. Another element could be a candidate's portal too.
